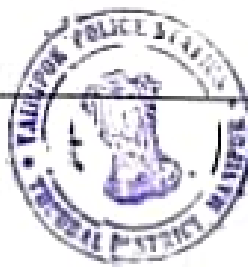

I, have the honour to report that today i.e, on 02/12/2024 at 12.30 pm my husband namely Md. Abdur Rahim have asked to one Md. Haider Ali (41)yrs. S/o (L) Md. Ahamed Ali residence of Phouden Mamang Leiaki about the pelting of stone to my house before 2/3 days back by one individual who was staying at the house of said Md. Haider Ali while he was coming at the courtyard of Md. Najir Ahamed S/o (L) Md. Tahir Ali of Phouden Mamang Leikai. In that the following persons, 1. Md. Zakir (55)yrs. S/o Md. Ibotombi, 2. Md. Liyakat (55)yrs. S/o (L) Md. Amin, 3. Md. Tomba @ Sahidur (45)yrs. S/o Md. Md. Ibotombi, 4. Md Heidar Ali (40)yrs. S/o (L) Ahamed Ali, 5. Md Alikhan@Sanjoy(38)yrs.S/o (L) Ahamed Ali, 6. Md. Alvas (20)yrs. S/o Md. Alikhan, 7. Md. Umar @ Boicha (25)yrs S/o Md Ibocha all of Phouden Mamang Leiaki suddenly attacked to me and my family members by holding dao (sword), iron rod, stick etc with intention to kill us. As a result of which my younger brother in-law namely Asip (30)yrs. S/o (L) Ibosana and my husband Md. Abdur Rahim (42)yrs. sustain cut injuries on their persons, while 1) Md. Latip Ali (30)yrs. S/o (L) Md. Rahimuddin, 2) Md. Mameiton S/o (L) Md. Ibosana, 3) Md. Tombi (24) S/o (L) Md Ibosana and myself sustained serious injuries on our persons


It is therefore, requested you to kindly take up necessary legal action against the unknown person/persons.
