With due respect and regards, I am reporting that, today 02/12/2024 at about 01:10 pm my family members, namely 1) Md. Heidar Ali S/o Late Md. Ahamed Ali, 2) Sarita W/o Md. Heidar Ali, 3) Sanjoy S/o Md. Ahamed Ali, 4) Umar Faruq S/o Md. Ibomcha, 5) Md. Dilshad S/o Md Ibomcha, 6) Md. Sahidur Rahaman S/o Md. Ibotombi, 7) Md. Yakir S/o Md. Ibotombi all of Phouden Mamang Leikai was assaulted by 1) Md. Abdur Rahim (42)yrs. S/o Late Md. Ibosana, 2) Sarabanu (40)yrs. W/o Md. Abdur Rahim, 3) Md. Saweed (40)yrs. S/o Late Salam Khan, 4) Sarifa(38)yrs. W/o Md. Saweed, 5) Md. Asip (30)yrs. S/o Md Ibosana, 6) Md Saroj (20)yrs. S/o Md. Ibosana, and 7) Md. Tombi (24) yrs. S/o Md Ibosana all of Phouden Mamang Leikai without any reason at the house of Md.
