

With due regards, I beg to state that today on 06/12/2024 at about 02.00 a.m. received a reliable information from RFT, Imphal CRPF that some unknown armed miscreants have stored and hidden some arms, ammunitions and explosives at foot hill of Pechi Chinglak near Culvert for using offensive act against State Security Forces and CAPF.

On receipt of the information, Special Operation Group (SOG) Thoubal District Police along with a column of 4 Assam Rifle, C/66 Bn. CRPF, led by Inspt. K.
