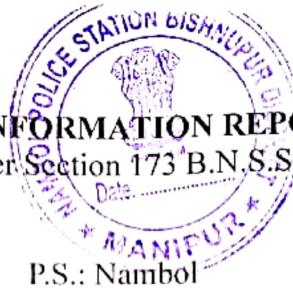

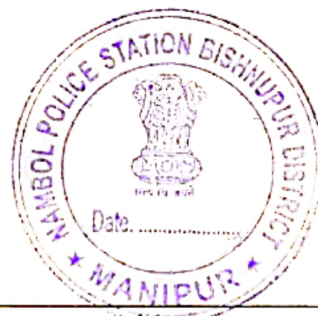

Today i.e. 16/09/2024 at 4:25 pm received a reliable information that on the same day at about 4:20 pm one unknown male pedestrian was knocked down by a Maruti Van bearing regd. No. MN07D-3296 driven by one unknown driver which was proceeding from Oinam side towards Imphal at Nambol Thongkha along Tiddim road, due to rash and negligent driving on the part of the unknown driver of Maruti Van.
