Today i.e. 22/09/2024 at 3:40 am received a reliable information that on the same day at around 1:40 am some unknown miscreants fired 10 rounds targeting one petrol pump namely Angoubi Energy Station (Indian Oil) located at Utlou along Tiddim road reportedly owned by retired Chief Secretary Oinam Nabakeshwor Singh. Some fired projectile marks were found on the building of the Energy Station including one Diesel Vending machine. No other damage or injury were reported in the said incident. It is suspected that the miscreants fled towards Imphal side by using Inter Village roads (IVRs) under the cover of darkness.

Hence, a Suo moto case under FIR No. 49(09)2024 NBL-PS U/s. 109(1)/324(4)/3(5) BNS & 25(1-A) A. Act is registered for investigation.
