Sir.

I am to report that today i.e. 22/09/2024 at around 4.00 pm on received a reliable information about the movement of armed miscreants to carry out prejudicial activities threatening general public with an intent to carry out extortion from general publics, business establishment institutions in an around Nambol areas.

Immediately, a combined team of CDO-BPR led by P. Sanjoy Singh, MPS., DSP (CDO-1) and Sub Y. Shaktisen OC/CDO-BPR assisted by ASI. H. Robash Singh and HC. Jayenta Singh of CDO-BPR along with the teams of Nambol Police Station led by Inspt. A. Nabakanta Sharma, OC/NBL-PS under the command of Amarjit Singh Lamabam MPS, Addl.SP-BPR(Ops) and under over all supervision of Shri. Ksh. Ravikumar Singh, IPS, Superintendent of Police Bishnupur conducted an int based combing and search operation at Khabam Bamdiar and its adjoining village areas.

During course of search operation, the teams conducted thorough search of the suspected areas and successfully recovered the under noted articles found cached and concealed at a dense area located at northern hill side of Machin Manao Ching of Chingmang Bamdiar and the same were seized at @ 5:23 pm by observing the formalities.

Particulars of the seized articles: -

- 1) One SLR B/R No. CN5350 with an empty magazine.
- Two nos. of RPG shell
- 3) Two nos. of RPG shell charger.
- 4) Three nos. of No. 36 hand grenade.
- 5) One Chinese Hand grenade.
- 6) One WT handset marked as "BAOFENG, UV-5R".
- 7) One old gunny sack and a plastic sack which was used in concealing the recovered weapons.

Hence, the seized items along with seizure memo have been handed over to NBL-PS for taking further necessary action.
