Sir,

I, the undersigned have the honour to report that in view of current prevailing law and order situation and to detect any kind of illegal and snatched weapon, incriminating articles concealed and to sanitize the fringe areas properly, today i.e. 10/10/2024 at around 5:30 am, under the supervision of Ksh. Ravikumar Singh, IPS, SP/Bishnupur and Amarjit Lamabam, MPS Addl. SP (Ops) Bishnupur conducted a joint cordon and search operation at the adjoining fringe area between Aigejang village and Uyok along Leimaram Makha Maning by a combined teams comprising of District Police Bishnupur led by Sub. Y. Sakti Shen, OC-CDO/BPR, assisted by SI. H. Haridas Singh CDO/BPR, a team of Nambol PS led by SI. Y. Arunkumar Singh and a team of 33-AR led by Maj. Devarshi Singh and a team of B-8 CRPF in presence of the Executive Magistrate Shri Akoijam Punshiba Meitei, SDC, Oinam. During the search operation, 2 (two) nos. of plastic bags were found concealed on the eastern side by pass path of the foothill IVR in between Aigejang village and Uyok. On opening the above mentioned bags, the following weapons, ammunitions, explosives and war like incriminating articles were recovered:
