Today i.e. 29/10/2024 at 06:30 am received a reliable information that on 28/10/2024 at about 7:50 pm one Honda Activa bearing Regd. No. MN01L-2203 ridden by one unknown rider which was proceeding from Khunpham Makha side towards Leimapokpam collided with one Maruti Van bearing Regd. No. MN03P-4770 driven by one unknown driver which was proceeding from the opposite direction at Khunpham Makha Leikai near crematorium along Chingphu road due to rash and negligent driving on the part of the unknown rider and driver of both the involved vehicles. As a result of which the unknown rider of Honda Activa received sustained injury on his person and evacuated to hospital for medical treatment. Both the vehicles were also partly damaged.

Hence, a suo moto case under FIR No. 55(10)2024 NBL-PS u/s 281/125(b)/324(4) BNS has been registered for investigation.
