Sir,

I, the undersigned have the honour to report that in view of current prevailing law and order situation and to detect any kind of illegal and snatched weapon, incriminating articles concealed and to sanitize the fringe areas properly, today i.e. 04/11/2024 at around 6:00 am, under the supervision of Ksh. Ravikumar Singh, IPS, SP/Bishnupur and Amarjit Lamabam, MPS Addl. SP (Ops) Bishnupur conducted a joint cordon and search operation at the adjoining fringe area between Aigejang village and Uyok along Leimaram Makha Maning by a combined teams comprising of District Police Bishnupur led by Shri D. Robinson, Dy SP-CDO-2/BPR, SI. Ph. Birkumar Singh, i/c OC/CDO-BPR including self assisted by ASI. H. Robash Singh, Hav. No. 1299418 Md. Islamuddin, Hav. No. 0920001230 Ch. Bobo Singh of CDO/BPR, a team of 2nd IRB led by Hav. No. 1207759 Th. Basantakumar Singh, teams of Nambol PS led by Inspt. A. Nabakanta Sharma, OC/NBL-PS & SI. Gonmei Jangmei, a team of 33-AR led by Maj. Devarshi Singh and a team of B-8 CRPF in presence of the Executive Magistrate Shri Akoijam Punshiba Meitei, SDC, Oinam. During the search operation, 2 (two) nos. of plastic sacks were found concealed on the eastern roadside of Uyok Nala.
