On 31/08/2024 at @ 5:25 pm, based on an information as furnished by volunteers of All Meitei Pangal Youth Association (AMPYA) Kwakta stating that one Md. Najeruddin Sangomsumbam (46) yrs s/o (L) Md. Kheiruddin of Kwakta Ward No. 2 (KMC) was picked up from his residence at Kwakta w Ward No. 2 along with suspected brown sugar. Immediately, a team of PGCI-PS led by myself rushed at the office of All Meitei Pangal Youth Association (AMPYA) at Kwakta Bazar. On that Md. Najeruddin Sangomsumbam 46 yrs s/o (L) Md. Kheiruddin of Kwakta Ward No. 2 (KMC) was found detained by the volunteers of AMPYA along with the recovered brown sugar(reddish in colour) containing in a transparent plastic packet and one Redmi mobile phone. It was also disclosed by the volunteers of AMPYA that the recovered brown sugar was filled inside five separated containers (four Khaini Kauta and one plastic bottle labelled as PacoEzyme). As the nature of offence is related with the NDPS Act, he was asked whether he would like to be searched his body before a gazetted officer or a magistrate. On that he opted that his personal search may be conducted then and there before a gazetted officer. Accordingly, information was passed to D. Robinson, Dy. SP-CDO/BPR (being gazzetted officer) through OC/PGCI-PS to be present at the Office of All Meitei Pangal Youth Association (AMPYA) at Kwakta Bazar for observing due formalities. D. Robinson, Dy. SP-CDO/BPR reached at the spot and started body search of the detainee in presence of civil witnesses. One transparent plastic packet containing the suspected brown sugar, four empty Khaini Kauta, one plastic bottle labelled as PacoEzyme and one Redmi Mobile phone was found from his possession. On weighing the transparent plastic packet containing suspected brown sugar, it was found 11 grams including the weight of the plastic container. 
