That, I Toswai Tholung got a call from my niece that some unknown persons knocked her door and tried to break her door, so I went out to look after into the matter and found 3 masked men were standing around her house of which one person was trying to forcibly entered the room by breaking the lock of the door. Immediately, I shouted and alerted people of the locality. On hearing my voice, some locals came to us. The village women folk run after them but they were so swift, passing through the neighbourhood pathway. So we could not reach them.

I prayed that necessary action will be taken on time for the safety of the people in my village.
