Sir,

I have the honour to state that today i.e 18/09/2024 at @ 9:45 pm I, SI N. Devdas Singh along with Police team of PGCI-PS led by self assisted by one team of CDO/BPR i.e Quebec-44 and personnel of 19th Gahrwal Rifle have jointly conducted normal frisking and checking duty at Kwakta Pangal Lamkhai along NH-02 Tiddim Road under the command of OC/PGCI-PS. In the meantime, 1 (one) lady was coming from Kwakta Bazar towards Kwakta Pangal Lamkhai side in a very suspicious manner. So, she was detained by our frisking and checking party to search her body as she was acting suspiciously. So, I informed to women police of PGCI-PS that I need to search her body. Accordingly, women police personnel immediately rushed to the spot. On arrival at the spot the detained lady who identified herself as one Nameirakpam Jaya Leima @ Yurthingla (49) yrs W/o N. Doren Singh of Nongada Makha Leikai under Lamalai PS, District-Imphal East, Manipur was informed to be searched her body of the person as she was acting suspiciously. So, I informed her that I need to search her body that she can opt to be searched in presence of either a gazette officer or an executive magistrate and the same was reduced in writing and read out the content to her. As per her option to be searched in presence of gazette officer. Further, the information was given to Shri D. Robinson MPS, Dy. SP (CDO-II), BPR and requested him for appearing at the spot and accordingly, after his arrival at the spot i.e. Kwakta Pangal Lamkhai and then we started checking the body of the lady and found 4 (four) separate soap cases concealing inside her body. On opening the soap cases filled with reddish powder suspected to be Heroin powder were found. On her preliminary examination, she brought the same from one known person namely Wungreingam @ Angam from Sanakeithel at present staying at Churchandpur (full particular not known) by paying a sum of Rs. 80,700/- and supposed to be delivered to one known person namely Aleng from Sabou village of Ukhrul District (full particular not-known). Thereafter, the suspected reddish colour Heroin powder was conducted weighing in presence of the Dy. SP (CDO-II), BPR, and was later marked as A1, A2 ... up to A4 respectively for identification and the respective weight of the suspected Heroine powder are as follows. A1-11 gms (including the weight of the transparent plastic packet). A2-12 gms (including the weight of the transparent plastic packet). A3-11 gms (including the weight of the transparent plastic packet), A4-13 gms (including the weight of the transparent plastic packet), and the total weight of the seized illegal drugs was found 47 grams including the weight of the transparent plastic packet and again, it was put inside a cartoon box marked as 'A' which was properly packed and sealed. The illegal drugs along with one mobile handset MI model having mobile N. 8132048601 (JIO) and 7627944905 (AIRTEL) respectively were seized from her possession in presence of the witnesses on the same day at 10:30 pm and later on she was arrested from the spot at 10:35 pm after observing all due formalities. The arrested person along with the seized items were handed over to you for taking further necessary legal action against her as per law.
