Sir,

I, the undersigned Ss Ruth Lamkang (55) yrs. W/o Ss. Shem Lamkang a residence of Thamlapokpi village PO Pallel, Chandel District Manipur would like to inform you regarding the following incident that had happened to us on the 17<sup>th</sup> December 2024 around 11:05 pm.

That I, Ruth heard knocking sound at my door at around 11:05 pm. I thought my son was back but I saw some unknown persons at my sumang through window, their face were covered, and I got scared and denied them to open the door. They continue to knock and bang at the door, at last the broke it and entered. They were with guns. They grasped my husband and dragged him. I jumped into the tussle, holding my husband on his waist screamed and shouted at the top of my lungs, alerting the neighbours. They tried to quiet my shouting by pressing my mouth and grabbing my neck in the meantime my son who was nearby heard me and came to rescue me but he was pinned down by other three men. They tried to pull gun trigger to him. So, I continued to shout alerting people, people responded by ringing electric post. They took away my husband's mobile phone son's mobile phone, driving license, Aadhaar card and money kept for house construction amounting about Rs.17,000/to Rs.20,000/-; and they flee into the woods towards my village cemetery as they heard the noise of people. In the midst of the incident, a 4 (four) year old child woke up from a deep sleep and witnessed the incident and she started mimicking the same in the morning.

I prayed that necessary action will be taken on time for the safety of the people in my village.
