

Sir,

I undersigned would like to report that on 15/02/2024 at around 7:30 am members of Arambai Tenggol, Meitei Leepun and State Forces like Manipur Police Commando and suspected Valley based Outlawed Organisation namely, People's Liberation Army (PLA) Cadres started unprovoked firing from Sugnu, Kakching District towards MB. Saichang Village, Sangaikot Sub-Division, Churachandpur District. The Security Forces deployed at MB Saichang retaliated the firing and heavy exchanged of fire took place. In the ensuing exchanged of Fire my Uncle (Elder brother of my Father) namely Jangkhonun Haokip (66) yrs who was extending our dwelling house at MB Saichang Village was hit by a bullet and injured on his head (near upper left ear) and was immediately evacuated to District Hospital, Churachandpur for medical treatment, however the injured being in precarious condition was later referred to Civil Hospital, Aizawl, Mizoram for further intensive treatment.

I therefore, request the Police to initiate a thorough investigation into this matter and take appropriate action against the individuals or groups responsible for this unfortunate incident. I am willing to cooperate fully with the Police and provide any necessary information to assist in the investigation.

I would also like to add that, I could not report in time due to law and order problem in the State.
