As endorsed, I have made an enquiry on the report submitted by Tingneilam Chongloi w/o Seiminthang Chongloi of Boljol Village, Ccpur, regarding Mr. Maunte (9862848461) stealing Spicing Machine i.e. Wifi connector from Loisei Investment office at Molnom.

Spoke with the complainant and found that Mr. Maunte was an employee in their office i.e. Loisei Investment office starting from May, 2024 with a salary of Rs.10,000/- per month and his salary paid till July, 2024. But due to the present situation their office couldnot pay the remaining salary due to three month i.e. August-October, 2024 amounting to Rs.30,000/-. That, it was learnt that on 18/11/2024 Mr. Maunte whose full particulars is Paukhanmuan (29) years s/o Thangthiangin of Bethel, Champhai, Mizoram have fled to Champhai, Mizoram stealing away office property i.e. Spicing Machine i.e. Wifi connector amounting to Rs.70,000/- (Approx).

Contacted Mr. Maunte (9862848461) and it was learnt that he have taken away the Spicing Machine i.e. Wifi connector as his three salary was not paid by the office. Instructed Mr. Maunte to return back the stolen item but was not returned back till date and he was also unwilling to come back to Manipur.

Recently, tried contacting Mr. Maunte (9862848461) but was not entertained/not picking up and ignoring to my calls. In this regard, a regular case needs to be registered as a cognizable offence was committed against Mr. Paukhanmuan @Maunte (29 years s/o Thangthiangin of Bethel, Champhai, Mizoram for investigation.

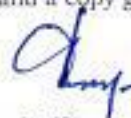

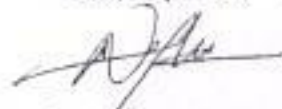
