I have the honour to report that on 03/05/2023 at about 5.00 pm, the following vehicles and items noted below, which were kept in front of Labour Camp located at Tuidam Village, PS:- Sangaikot, District:-Churachandpur, Manipur for execution of the contract work for Construction of Road from M Lhahvom (Misao Lhahvom) to Tuidam of Churachandpur District for PMGSY under Package No. MN 03150 of Phase -XI(B-II) of Spl. Class Contractor Vs. Gaikholung Panmei were abandoned due the sudden outbreak of the ethnic crisis since 03/05/2023.

I cannot report the matter in time, as I have communicated/ in touch with (i) Namcha (34 years) of Khongkhai Village (Cont. No. 7085258111) and (ii) Ngamboi (35 years) of Chaljang Village (Cont. No. 8132884220) about my vehicles and other items mentioned above. They also assured that they will look after the said vehicles and other items. However, in the last few days they neither picked up my call nor updated any information about the matter. Later, it is learnt that the above noted vehicles/items were stolen by the unknown miscreants.

It is therefore requested kindly to take up necessary legal action against the miscreants.
