Subject: FIR against theft of Telecom Equipment i.e. Battery bank, DG, PPC, Copper cables at our Mobile Tower UMP167 (IN-2063001)

Sir,

With reference to the subject cited above, this is to inform you that on 7/04/2024 16:00:00 PM, site outage alarm was received in our system from UMP167, Sangu, W/O- P. Dongzalam, Vill- P. Suahzahau, PO&PS-Singngat, Dist-Churachandpur, State-Manipur, Pin-795139.

Accordingly, Chingsuanmang-9774084228 visited the site on 7/04/2024 16:00:00 PM and found that some unknown miscreants had barged into the tower site and stolen away the network equipment, namely, Battery bank, DG, Delta IPMS on 7/04/2024 16:00:00 PM with an ulterior motive of monetary gain and disrupting the communication.

The Battery bank, DG, Delta IPMS are device which supply power and deployed at Airtel mobile towers for maintaining communication and it is installed mainly at the base of the mobile.

Frequent unabated thefts of these kinds of equipment from our tower sites have impacted the very communication network though replacements of the equipment subject to availability is made immediately to maintain network. It is to be mentioned here that because of the huge number of thefts taking place in the Circle, we are running short of such a stock of equipment for replacement.

In view of the above, I request you to kindly register a case in this regard and investigate the same to bring the culprits to book and recover the stolen items at your earliest possible.
