**SUB- TO LODGE A FIR AGAINST KLA CADRE**

1. Regular area domination was conducted today by COB Sangaikot and COB T Khongkhai, ex-36 AR, under Lt Col Sakil Ahmad and Maj D P Singh, respectively, along the Manipur River corridor with strengths of 01 offr, 01 JCO and 20 OR each.
2. At 1100 am, both columns had linked up in general Area Bijang (Approx 15 km south-west of Sangaikot), wherein they found three suspected cadres with weapons. On challenging them two cadres ran away and the remaining cadre was cornered by own troops. Own columns immediately cordoned the area; however, women surrounded the cadre, incl approx 100 locals women folks surrounded own columns.
3. You are requested to book the suspected KLA cadre named Minshy for
  - (a) Attempting to wage war and cause bodily harm to SF and Civilians
  - (b) Indulging in extortion activities
  - (c) Instigating the mob to act against SF
  - (d) Violation of SoO ground rules.
4. Therefore, you are requested to book the cadre under the relevant acts, including the National Security Act for waging war against the Union of India.
5. The fwg wpns and WLS have been recovered from the apprehended cadre.
