



Sir,

I have the honour to report that today i.e. the 15<sup>th</sup> June 2024 at @ 6:30 pm, I saw my grandmother namely Mrs. Luankhozam Biangtung lying with a pool of blood facing the floor at our common room. I got shocked and did not have the guts to look at her. So I rushed directly to my neighbour namely Mr. Manglianlal Milun and informed him about the incident.

The same day, at @ 12:00 pm my mother left the house and I stayed alone with my grandmother. And at @ 2:00 pm my uncle namely, Mr. P. Mangzakhup (63) of Immanuel Khopi, Churachandpur came to our house to repair our Almirah. After repairing our Almirah at @ 3:30 pm, he left the house. Thereafter, I stayed alone with my grandmother. And at @ 05:00 pm, my mother namely Baby Chinneikim rang me up over my mobile phone and informed me to come to her at Old Bazar. I was with my grandmother till then. So, I dressed up myself and also informed my grandmother that I was called by my mother. Then, I left my house and also closed the gate of our house. And at @ 6:30 pm, while I was returning back home after meeting my mother, I saw the gate of our house being opened and also the door of our house was locked from outside. As I opened the door of our house, I saw my grandmother namely Mrs. Luankhozam Biangtung @ 80 years W/o (L) Ginkhozam Biangtung of Immanuel Khopi, Churachandpur lying on the floor in a pool of blood.

In the light of the above facts and circumstances, I request our respected madam to kindly booked the culprit who is behind the murder of my beloved grandmother and give stringent punishment as per the law of the land.
