<u>Subject:</u> Report against the killing of **Mr. Thangkhochon Haokip (31 years)** S/o (L) Sumkhoson Haokip, a resident of **Selkui Village, Chandel District, Manipur.** 

## Respected Sir,

With grief and concern, I have the honour to make this First Information Report to you regarding the unfortunate incident of bombing and killing of the above-named victim, which I do as under:

- That, I am the wife of the above mentioned victim namely, Mr. Thangkhochon Haokip. We belong to the Thadou-Kuki Tribe, a Scheduled Tribe under the Constitution of India, and the victim is a permanent resident of the address mentioned above.
- That, on the 30<sup>th</sup> of September, 2023 at about 6:30pm, the above-mentioned victim was a village volunteer on duty at a duty post located at Lailoiphai Village, Churachandpur District. The said victim was shot dead during an attack by unknown miscreants suspected to be from Meitei Community.
- That, the attack on the said victim was carried out because he belonged to the Kuki-Zo tribal community and that he is a victim of the ethnic violence that erupted since May 3<sup>rd</sup>, 2023.

I, therefore, request you to kindly register my report, investigate the matter; arrest the culprits involved in the gruesome act and book them under relevant sections of the law of our country. And for this act of kindness, I shall always be grateful to you and obliged.
