I the undersigned would like to inform you that on the early morning of 28th August, 2024 around 02:10 am-02:45 am, my wife Mrs. Niangngailun (55 years) was attacked by one unknown miscreant at New Bazar (opposite to Manipur Presbyterian Church, Centre School, I.B Road Small gully entry to New Bazar) while going to fetch vegetables for her local store.

She suffer 3 (three) cuts in the head and was robbed off her bag containing Rs 2220. She remain unconscious and was further taken to District Hospitals by Mr.Gouboi Gangte (Mob. No. 8416040431) to seek medical attention and was discharged later on.

Madam, I urged your kind intervention to investigate and arrests the assailant and brought to justice as soon as possible.
