1. MVCP placed under Maj Amit Kumar Mishra along with 01 JCO and 15 ORs near Sangaikot junction intercepted a passenger Bus (Regd No MN 05 C - 0967) on 31 May 2024 at 1020 AM coming from T KHONKHA and going towards CCpur. On Thorough check a 22 years old individual named Ginlunlen William, S/O Ginsuonmung, r/o Kholian under Chakiparong Subdivision, District Chandel was caught under possession of 60 x Soap Cases of Brown Sugar, weighting 2.3 kg (weight of soap cases included). Total 676 gm of Brown Sugar without soap cases amounting to 135 Cr Rupees.
