Subject: Report on Attempt to Murder; Criminal intimidation with a threat to cause death or grievous hurt; Criminal Trespass WITH Common Intention.

Sir,

I, the undersigned, have the honor to present the following statements of facts for your kind perusal and considerations praying for strict investigation of the matter and take appropriate action by due process of law:-

1. That, I am the Chief of D.Lhangjol Village, situated within Churachandpur District, Manipur, and I have filed a Declaration Suit in the Court of Civil Judge, (Jr. Divn.), Churachandpur, in regards to the illegal activities carried out by some miscreants within my village land which was registered as being O.S. (Decl.) Case No. 12 of 2021(Letkholal Khongsai Vs Thanglal Haokip and Others) accompanied by Judicial Misc. Case No. 26 of 2021 praying for passing an Ex-Parte ad-interim Injunction in favor of me. The said Hon'ble Court vide its Order dated 18.04.2022 was gracious enough to grant an interim injunction with regards to the Judicial Misc. Case No. 26 of 2021 by restraining the Principal Defendant No. 1 to 5 as follows:

“Para. No. 16.1: That, the Opposite Parties/defendants are hereby restrained from disturbing the peaceful possession of the Schedule land by the petitioner/plaintiff until the disposal of the main suit.

Para. No. 16.2: That, the Opposite parties/ defendants are hereby restraint from felling/cutting of trees, timber, bamboos within the said Suitland pending adjudication.

Para. No. 16.3: That, the Opposite parties/defendants are hereby restraint from engaging in construction of any permanent structure within the suit land until disposal of the main suit.”

Schedule A

SUIT LAND

An unsurveyed hill land measuring about 296.52 paris situated within Dampi Village land now referred to as D Lhangjol Village within Churachandpur District, Manipur which is bounded as under

North : Molsang
South : Tuilelon Vadung
East : Phailei Kom
West : Moltou Lhang

It may be pertinent to mention here that, the Hon'ble Judge, Civil Judge (Junior Division), Churachandpur, while passing the Interim Injunction Order has forwarded the same to the O.C. Churachandpur P.S. for taking up necessary action but appropriate steps is not taken up till the filing of this complaint. Also, when I informed the O.C. Churachandpur Police Station about the recent criminal activities committed by the said Mr Thangkhohao Gangte, aged about 42 Years, S/o Limzalet, and his gang, on 7th January, 2024, I was instructed by the O.C. Churachandpur Police Station, to filed a criminal complaint before your esteem office as the PO falls under your Police Jurisdiction and is now functioning properly.

Photocopy of the Interim Order dated 18.04.2022 passed by the Hon'ble Civil Judge (Junior Division) Churachandpur, is hereby enclosed and marked as **DOCUMENT-A**.

2. That, I am informing with great disappointment that there was a violation of the above-mentioned interim injunction from time to time and the same was duly reported to the Officer-in-Charge, Churachandpur Police Station, Churachandpur, on dated 18.07.2022, 2.11.2022, 13.12.2022 and 20.1.2023 respectively. In the meantime, Disobedience Suit in the form of Judicial Misc. Case No. 27 of 2021 is also filed before the Hon'ble Civil Judge (Junior Division) Churachandpur, and the matter is still under consideration.

A photocopy of the Complaints filed before the Officer-in-Charge, Churachandpur PS are hereby enclosed and marked as **DOCUMENT-B, DOCUMENT-C, DOCUMENT-D & DOCUMENT-E** respectively.

3. That, in the meanwhile, Mr Thangkhohao Gangte, aged about 42 Years, S/o Limzalet, a resident of Headquarter Veng, Chiengkongpang Village, Churachandpur District, Manipur, claiming to be the Chief of a self-named T. Gamnom Village, Saikot Sub-Division, Churachandpur District, Manipur, **within my village land has repeatedly disturb my peaceful possession by way of illegally cutting/felling trees, timber and bamboos within the suit land and engaging in construction of permanent structure within the suit land; by claiming my scheduled land/the suit land of the above-referred case.** The unfounded claim of Mr Thangkhohao Gangte, is that he has allegedly purchase a piece of land from Mr Onpao Haokip, who is the younger brother and the privies/man/agents or representatives of the Principal Defendant No. 1(Thanglal Haokip) of the above-mention suit/case whereas the alleged purchased and the claimed village is absolutely lying within my village scheduled land/suit land thereby meaning that it is very much within my village scheduled land.
4. That, besides violating the Interim Injunction Order of the Court, **the said Mr Thangkhohao Gangte, along with his gang members numbering around 20(twenty) on the 6th January, 2024, at around 12:00 Noon, by carrying knife, dow and sticks has trespassed into my village land and threatened some of the villagers who went to do their daily work like collecting straw for constructing a thatched roof; cutting wood/bamboo for household needs; and harvesting ginger from their village farm. The villagers are forced to abandoned their work place and run for their life when Mr Thangkhohao Gangte, and his gangs intimidate and terrified the villagers by threatening to kill them if they sees them around again.**

5. That, in the afternoon of the same day i.e. 6.1.2023, at around 2;00 PM, the said Mr Thangkhohao Gangte, along with his gang members numbering around 20(twenty) has intrude into my village and bragged about his action in front of my house and warn us of a dire consequences if the villagers come out to the village land without obtaining a prior permit from him and left after I calmly suggest him by telling that " the land dispute matter is a sub-judice so if you have anything to raise, it will be more prudent of you to approach the competent court."

A captured print out image/photo of Mr Thangkhohao Gangte gang' patrolling around my village land is hereby enclosed and marked as **DOCUMENT-F.**

6. That, on the 7th January, 2024, the said Mr Thangkhohao Gangte, sent an emissary who hand over a "Threat cum Summon Letter" to me which says;

FREE TRANSLATION

"To,

Mr Letkholal Khongsai,

You are directed to report to me by 2:00PM of Date 7.01 2024 and bring the Permit which was issued to you by T Gamnom for cutting/felling trees and for doing cultivation/farming to clarify your grounds. You will be bar from any privileges on the event of failing to report and if you faced any consequences upon your failure to report, it will be your own doing. You are hereby prohibited from collecting/cutting wood and cultivating a land from now on.

Cheip of: Pu Thangkhohao Gante "

A photocopy of the Threat cum Summon Letter is hereby enclosed and marked as **DOCUMENT-G**.

7. Again, on the 10th January, 2024, the said Mr Thangkhohao Gangte, along with the same numbers of his gangs intrude to my village and patrolling around my village land by carrying fire arms and other deadly weapons like knife and rod and drives out the villagers and creating havoc and disturbing scene in front of innocent women and children within my village land. After that, he left a very disturbing and intimidating NOTICE beside my house which read, *"Collecting/Cutting Wood and Cultivating land is prohibited within T Gamnom Village Land, Offenders cannot blame anyone for violating the Notice."*

A print-out copy of the captured Notice is hereby enclosed and marked as **DOCUMENT-H**.

8. That, his barbaric actions as submitted herein **has endangered my life and the peaceful atmosphere of the village and its surroundings**, his dead threat has terrified my villagers who are now scared to step out from their own house, the whole villagers are also frightened that Mr Thangkhohao Gangte and his gangs may come and kill them anytime now. Moreover, his actions have become prejudicial to the maintenance of harmony and are disturbing the public tranquility as well.

In view of the above stated facts and circumstances I, therefore, request your good office to initiate inquiry/ investigation against the act and conduct of Mr Thangkhohao Gangte, aged about 42 Years, S/o Limzalet, a resident of Headquarter Veng, Chiengkongpang Village, Churachandpur District, Manipur, claiming to be the Chief of a self-named T. Gamnom Village, Saikot Sub-Division, Churachandpur District, Manipur, within my village land

along with his gang members numbering around 20(twenty), AND investigate the matter thoroughly in order to prosecute and punish them in accordance with the law of the land.
