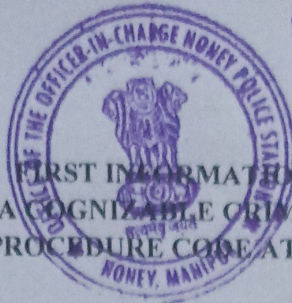

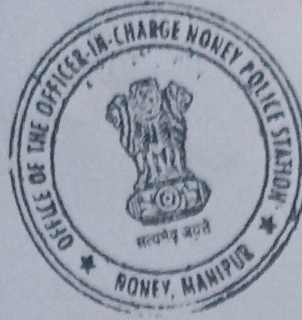

Subject: Request for taking legal action for looting of NFSA food grains from my FCI truck  
Bearing Registration No.AS01T-6247 at Awangkhum Part-1 Village by Unknown miscreants.

Sir,

With reference to the subject as cited above, it is to request you for taking up appropriate legal action for looting of NFSA food grains from the above mentioned FCI trucks en-route from Jiribam to Imphal by appreciating the below narrated facts.

That is on 17/07/2023 at around 8:30pm, while I was driving one Tata Truck bearing registration No.AS01T-6247 loaded with 310 bags of FCI (Rice) for Imphal along with my helper namely Khangjenbam Hero (40yrs) of Loitang, Sekmai, Imphal West. Some unknown miscreants numbering about 8-9 person detained at Awangkhum Part-1 Village near the border Rangkhung Village. They pulled me down from the vehicle and forcefully unloaded 10 bags of FCI Rice from the vehicle at the spot. After unloading they allowed me to leave immediately from the spot. Further they threatened me not to inform to Police/Central Security Force in future.

Therefore, it is requested to take appropriate legal action against the involved unknown miscreants as per law.
