Today i.e. 12/09/2023 at 4:00 pm, received a reliable information that on the same day i.e. 12/09/2023 at around 11:45 am, a gunshot was fired by unknown miscreants on one of the convoy vehicles coming from Jiribam towards Imphal near Petrol pump of Noney, Noney District, Manipur about 6 km North/East of Noney Police Station. The vehicle is an Oil Tanker (Petrol) bearing Regn. No. MN01AA-0407 driven by one Haodujam Robi Singh (52) yrs. S/O H. Babu Singh of Wangkhei Khunou Old Checkon, Imphal East District, Manipur. As a result of the incident, the helper side door of the involved vehicle was hit leaving a mark of the bullet.

Hence, a Suo-motto Case under FIR NO. 11(09)2023 NNE-PS u/s 384/427/400/34 IPC & 25(1-C) A. Act has been registered for investigation.
