First Information contents: Today i.e. 01/11/2024 at 4:30pm, Shri Letkholal Khongsai lodge a written report to OC/SKT-PS stating that, on 31/11/2024 noon about 30(thirty) numbers armed and weapons stormed inside his village land in one white D.I Pickup vehicle at about 2:30pm while parking 2(two) Boleros and some cars besides the main road at Sugnu Road. They destroyed the Signboard he erected on the main way to his village wherein it was displayed Welcome to Dampi Lhangjol Village, They collected mobile phones of those present at his village and poured petrol over his house and set his residential house on fire while his grand-daughter aged about 4(four) months old was sleeping inside the said house(.) and they also warned them to get enrolled as T.Gamnom Villagers failing which they will burnt their houses like they did to him. Hence the case(.)

Subject : Report regarding attempt to murder, organized crime, wrongful confinement, use of criminal force and arson.

Sir,

I humbly state the following for your kind information and immediate necessary legal actions:-

- (i) That, I am the Chief of D. Lhangjol Village and I filed an Original (Declaration) Suit bearing No. 12 of 2021 against the illegal encroachers of my village land before the Hon'ble Civil Judge, Junior Division, Churachandpur on 16-06-2021 and after hearing the parties therein, the Hon'ble Civil Judge, Junior Division, Churachandpur vide its Order dated 18-04-2022 passed an injunction order against the principal defendants therein restraining them from disturbing my peaceful possession of my village land, restrain them from felling trees etc., or construction of any permanent structure until the disposal of the main suit. The main case is still pending final adjudication before the said Hon'ble Court.
- (ii) That, while the above suit was proceeding, Shri Thangkhohou Gangte, aged about 43 (*Forty-three*) years, S/o: Limzalet, a resident of Headquarter Veng, Chiengkongpang, Churachandpur, Manipur, *a Self styled Finance Secretary of the United Tribal Liberation Army*, illegally claimed ownership and possession of a part of my village land after he claimed to acquire the same from one Shri T. Onpao Haokip, S/o: (L) Jangkhoson Haokip, a resident of a village illegally set up within my Village land. Shri T. Onpao Haokip is the elder brother of the Principal Defendant No. 1 in my above said case and I am in the process of impleading the said Shri Thangkhohou Gangte as defendant in my said case.
- (iii) That, Shri Thangkhohou Gangte and his men, without any lawful authority have been causing several disturbances in the past and I have filed several complaints against him before your esteemed office but no concrete actions were ever taken against him.
- (iv) That, on 31-10-2024 noon, while I along with most of my Villagers went for harvesting paddy, for reasons best known to them, Shri Thangkhohou Gangte along

with his men, about 30 (thirty) in numbers, armed with sophisticated arms and weapons stormed inside my village land in one white D.I. Pick up vehicle at about 2:30 p.m. while parking 2 (two) Boleros and some cars besides the main road at Sugnu Road. Only a few villagers and children were in my village at that time. They destroyed the signboard I erected on the main way to my village wherein it was displayed 'Wel-come to Dampi Lhangjol Village' and they put up a board stating 'T. Gamnom gamgi nahoidung galngam sel khun - Sunga lou lho thing poh phal ahi ta poi.' meaning 'No one is allowed to farm or collect timber inside this T. Gamnom village'

- (v) On arriving inside my village and at my place in my absence, they first destroyed the CCTV Camera I installed around my residential house, after which they collected the mobile phones of those present at my village and poured petrol over my house and set my residential house on fire while my grand-daughter aged about 4 (four) month old was sleeping inside my said house who was latter rescued by my daughter-in-law. Most of my properties therein including our almirahs, refrigerator, Computer, clothings, household items and utensils, furnitures, etc. were reduced to ashes. They won't let my aunt, aged about 81 years to even collect her clothings. They warned my villagers not to douse the fire while pointing their sophisticated arms and weapons at them. They also warned them to get enrolled as T. Gamnom Villagers failing which they will burn their houses like they did mine. One of my villagers captured parts of the incident stealthily from inside their house.

They left back in a hurry and accordingly, my villagers rushed to collect some few items from my kitchen in the side yard of my main house.

- (vi) That, my villagers were able to identify the following persons involved in the commission of the crime:
- (1) Shri Thangkhohou Gangte, S/o: Limzalet, a resident of Headquarter Veng, Chiengkongpang, Churachandpur, claiming to be the Chief of T. Gamnom Village who illegally set up the said village in the year 2022.
 - (2) Shri Letthang Haokip, acting Chief of Khodang cum Secretary, Sangaikot Sub-Division Chief's Association, Sangaikot.
 - (3) Shri Janglal Mangte, Commander, Sangaikot Sub-Division Village Volunteer, Sangaikot.
 - (4) Shri Sonkholun Haokip, (in-charge) KNO/KNA Salem Camp accompanied by about 7 (seven) cadres of KNO/KNA Salem Camp.
 - (5) Shri Soneithang Khongsai of T. Gamnom Village illegally set up inside my village land.

- (6) Shr Ginsuankhai, Chief of Tuinning & Chairman, Sangaikot Sub-Division Chief's Association, Sangaikot.
- (7) Shri Songam Haokip of T. Yangmun Village & Adviser, Sangaikot Sub-Division Chief Association, Sangaikot and
- (8) Shri Holmang Baite, Chief of H. Makhao Village & Secretary, Sangaikot Sub-Division Defence Committee.

It is pertinent to mention herein that the Sangaikot Sub-Division Chief's Association had warned and threatened me in writing on 03-09-2024 which indicates that they are also equally responsible for the commission of the crime mentioned above. Therefore, based on the above stated facts and circumstances, I humbly seek your immediate intervention and take immediate legal necessary actions against the above named persons as well as their accomplice as per law of the land for the ends of justice.
