(1) First Information contents: Today i.e on 14/11/2024 at 2:00 Pm, Shri Letkthothang Haokip, Secretary, SSDCA lodge a written report to OC-SKT PS stating that on 08/03/2021 at around noon, One Letkholal Khongsai, of D. Lhangjol alongwith his private militia/volunteers disturbed the villagers of T. Molhoiphai who went to the paddy field injuring 12 innocent villagers. Among them one Mrs Tinkholam W/o Letkholal Touthang has a miscarriage and one Mr. Doujathang has permanent impaired eye.

(2) That, on 01/01/2022, Mr Letkholal Khongsai and his accomplices set on fire the dwelling home of Mr. Lhunkholet at T.Gamnom village. He is still evading settlement before the Customary Court of SSDCA.

(3) That, on 28/03/2024, Mr Letkholal Khongsai and his accomplices using his Dao/Khukri created ruckus at T. Gamnom village and threatened the villagers.



Subject: Report against Mr. Letkholal Khongsai S/o (L) Jamkholet Khongsai of D. Lhangjol Village for criminal intimidation, threat and forming of private militia.

I on behalf of the Sangaikot Sub-Division Chief Association (SSDCA), Sangaikot, Churachandpur would like to lay down the following for favour of kind consideration and urgent necessary legal action.

1. That, the Sangaikot Sub-Division Chief Association is a conglomerate of 126 Villages and Machetes within Sangaikot Sub-Division, with a set of guidelines and mandate, working tirelessly for the general welfare of all the public within its jurisdiction. The case against Letkholal Khongsai of D. Lhangjol Village has also been taken up and decided by the SSDCA providing ample chances for representation. However, owing to the alleged incident happening on 31-10-2024 at D. Lhangjol Village, the said Letkholal Khongsai has put the blame on the esteemed members of SSDCA which has no hand whatsoever in the alleged crime. That, the said Letkholal Khongsai has developed a personal grudge against the esteemed members of SSDCA, thereby defaming the legitimate organisation through various social media platforms on wrong charges.
2. That, brief criminal history of Letkholal Khongsai can be described and verified as follows:
 - i. The said Letkholal Khongsai is a native of Moljol Village under Chandel District and having completed a course in Biblical Theology he worked as a Pastor under Kuki Christian Church (K.C.C). However, due to his dealings in illegal business, he stepped down from his work as a Pastor. Sometime in the year 2021, along with some disgruntled villagers of Moljol Village, he settled at D. Lhangjol Village under Sangaikot Sub-Division, Churachandpur.
 - ii. The said Letkholal Khongsai right after settling in D. Lhangjol Village on 08-03-2021 at around noon with his private militia/volunteers disturbed the villagers of T. Molhoiphai who went to the paddy field injuring 12 innocent villagers. Among them one Mrs. Tinkholam W/o Letkholal Touthang has miscarriage and one Mr. Doujathang has permanent impaired eye.

- iii. The said Letkholal Khongsai using his S.D.O Tuibong Sale Deed No.92(A) dated 11/04/2017 threaten and disturbed the peaceful possession of the villages namely, Molhoiphai, T. Phaijol, Tuilelon, Saheiphai and G. Luihoi Molcham village, which were existence before the said D. Lhangjol village illegally created and settled in by the said Letkholal Khongsai. The said 5 villages have filled a complaint to the SSDCA Customary Court as per rules and norms and the said Letkholal Khongsai rejected the complaint by not appearing and presenting his case in defiance of the customary court of SSDCA. Later on SSDCA referred the case to Deputy Commissioner Churachandpur in which ultimately the recognition of D.Lhangjol village was cancelled by the Deputy Commissioner, Churachandpur Order vide No. Rev-CP-1/1/2022-DC(CCP) dated 28th April, 2022.
 - iv. That, the "Tuiteng Lourup Dam Committee cum Farmer Association" has also filed a compliant to the SSDCA on the frequent disturbances and threat to life given by Letkholal Khongsai claiming a large area of paddy cultivation area as his own. However, on examination by the SSDCA, the paddy owners have bonafide Pattas issued by the competent Government Authority whereas the said Letkholal Khongsai relied on the cancelled and void Sale Deed aforementioned.
 - v. That, on 01-01-2022, Mr. Letkholal Khongsai set on fire the dwelling home of Mr. Lhunkholet at T. Gamnom Village. He is still evading settlement before the Customary Court of SSDCA.
 - vi. In the year 2022, the said Mr. Letkholal Khongsai was been arrested for allowing Poppy Cultivation on the alleged land he claimed defying the diktat of the SSDCA prohibiting Poppy Cultivation within the jurisdiction of SSDCA.
3. That, the Sangaikot Sub-Division Chiefs Association on 03-09-2024 has issued a declaration to enable settlement of the pending case of the land of D. Lhangjol Village and surrounding villages. However, the said Letkholal Khongsai remained defiant and even threatened the SSDCA members and surrounding villages by deploying armed private militia/volunteers, creating a sense of insecurity and disturbing the harmony of the area.
 4. That, on 28-03-2024 Mr. Letkholal Khongsai using dao/khukhri created ruckus at T. Gamnom Village and threaten the villagers.
 5. That, in view of the above stated facts and circumstances, the presence of Mr. T. Letkholal Khongsai within the jurisdiction of SSDCA has created lawlessness, insecurity in the minds of the villagers and the public at large.

6. That, it is specifically reported that the said Mr. Letkholal Khongsai has created a private militia/volunteers armed with sophisticated weapons wandering the area in and around D. Lhangjol Village within the jurisdiction of SSDCA creating fear psychosis among the villagers and passers-by which can eventually turn into a big law and order problems unless the said Letkholal Khongsai is apprehended and taken to task.
7. That, it is also specifically reported to your good office that the said Letkholal Khongsai has threatened the SSDCA with severe consequences and criminally intimidated the office bearers of SSDCA through Social Media Platforms thereby endangering the life of the SSDCA along with the general public.


In view of the above, it is humbly prayed that FIR be registered against the accused Letkholal Khongsai under relevant provisions of law and urgently book him so as to ensure peace and stability within the jurisdiction of SSDCA.

Whereas, Sub-Divisional Officer, Tuibong had issued order vide Order No. 2/14/2016/SOO-IBG/(Machet) dated 9th June, 2017 allowing/recognition D.Lhangjol as a Machet of Dampi Village, Tuibong Sub-division, Churachandpur District.

Whereas, D.Lhangjol falls within Dampi Reserved Forest;

Whereas, Divisional Officer, Churachandpur Forest Division vide letters of even no. No.7/23(B)/2020-21/DFS dated 22nd February, 2021 and 4th January, 2022 addressed to Sub-Divisional Officer, Tuibong with a copy endorsed to Deputy Commissioner, Churachandpur had reported encroachment of D.Lhangjol Village inside Dampi Reserved Forest.

Whereas, as per the order No.55/12/86 For dated 31st May, 1994 of the Secretariat, Forest Department, Government of Manipur, "Establishment of village within reserve forest areas needs to be done only after approval of the concerned authorities are obtained in writing. Recognition of such village/villages without prior approval violates provisions under Section 709(d), 79,82, of Indian Forest Act, 1927 and Rule 81 of Manipur Forest Rules, 1971 as well as section 2 of the Forest(Conservation) Act, 1980. The Government of Manipur hereby ordered that for recognition of hill villages, the Deputy Commissioner concerned should henceforth refer the matter to the concerned Divisional Forest Officer before giving such recognition;

Whereas, Sub-Divisional Officer Tuibong is not authorized to give recognition to village;

Now, therefore, the aforesaid order issued by Sub-Divisional Officer Tuibong dated 9th June, 2017 is hereby cancelled/rescinded with immediate effect.

Sir,

It is to state that there was a confliction and physical forces between the people of Molhoiphai and Team of Shri Letkholal Khongsai on the 8th March 2021 at 12:00 p.m where some of the serious injured were taken up to District Hospital Churachandpur then upto Sajiva Jail. Then, it is further to know you that the team of Shri Letkholal Khongsai came to beat and harassed Molhoiphai people where very serious injured were put up at District Hospital Churachandpur on 31st May 2021 at 1:00 p.m.

In this regard, the SSDCA have found the problems came upon due to the co-registration bearing Deed of Gift No. 22/2001 dated 14/05/2001 done by Churachandpur SDO and Deed of Sale bearing no. 92(A) dated 11/04/2017 done by SDO Tuibong for favour of Mr. Letkholal Khongsai which create problem as such.

It is to state also that the Sale Deed done by Tuibong SDO under No. 92(A) on 11/4/2017 have effected problem on 5 villages viz.

- i, Tuilelon Village,
- ii, Saheiphai village
- iii, Lulhoihmoulcham village
- iv, Molhoiphai village
- v, T. Phaijol village

In this connection, the aforesaid five villagers were forbidden by Mr. Letkholal Khongsai of carrying fire-woods, cultivation of any piece of land, which created more crisis and problem herewith.



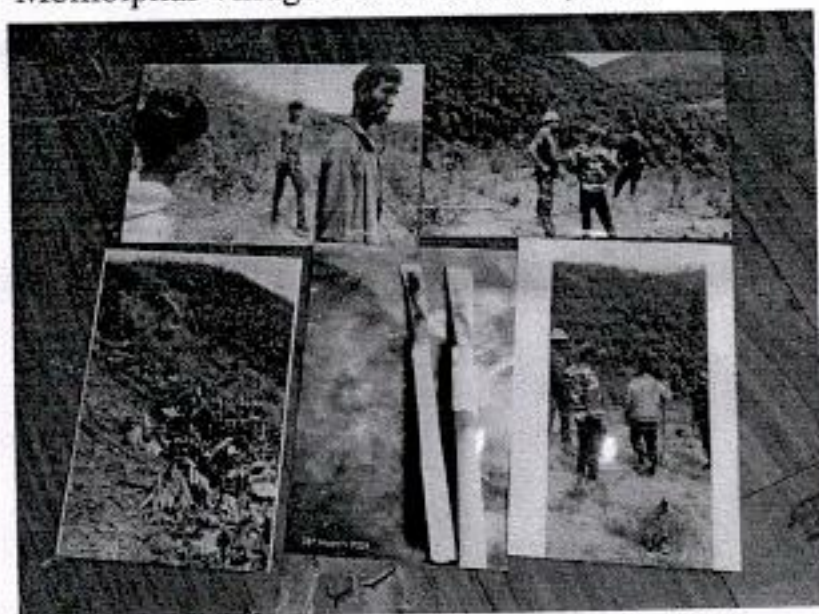
