

Subject : Request to take up FIR against suspected Cadres of People Liberation Army (PLA) and Arambai Tenggol deu to firing of Two inch Mortar bomb at G.Songgel Village.

Sir,

We, the undersigned of the Village chiefs of G. Songgel areas have the honour to inform you that, today( i.e,16/12/2023) at @ 11:40 am, the Meitei Militants suspected to be Cadres of People Liberation Army (PLA) and Arambai Tenggol have fired 3(three) rounds of two-inch Mortar Bomb from Tangjeng Khunjao (Mangjing) towards G. Songgel Village and one of the bombs landed and exploded at G.Songgel near the vicinity of 1(one) Tea hotel and 2(two) residential houses and it was followed by firing of another 7 (seven) rounds of Automatic Rifles towards Leisan and Mollum side. The explosion of the said bomb causes partial damages to the walls of Tea Hotel and 2(two) Houses including injury to one person on his left hand wrist namely, Mr. Jamkhomang Baite (25) yrs of age s/o Shri.Thongkholim Baite of Patjang village, who came near the tea hotel at the time of incident.

In this connection, it may be mentioned that after the blast on the spot, the tail of the Bomb was found attached with binding wire/string. As such, a suspension is prevailing in the minds of general public which needs to be verified with bomb expert to the effect that whether Drone was used to drop the bomb since a binding-wire/string was found being attached with the tail of the Bomb.

In view of the reasons and reports stated above, the Sangaikot PS is requested to kindly take up an appropriate FIR against suspected Cadres of PLA and Arambai Tenggol as perpetrator/culprit and punish them according to the laws of land/IPC, so that such incident of firing of two inch mortar bomb among residential and civilians area are avoided in future.
