Later on he come to know that all his valuable household properties were vandalized and looted by some unknown Kuki armed miscreants. The approximate value of damaged/looted properties is Rs.10,000,00/-(Rupees Ten Lakhs) approx..

Sir,

With due respect, I have the honour to state that before ongoing communal violence incident between Kuki and Meitei communities was erupted, I along with my family members were stayed in a rented house at Sangaikot Bazar of Churachandpur District owned by Seithang resident of Sangaikot Bazar, Churachandpur District. I was also opened a shop for cloths and other various items in the said rented house.

However, because of the communal clashes between Kuki and Meitei communities was erupted from the 3<sup>rd</sup> May 2023, I along with my family members fled away from the rented house to save our lives and all my valuable properties including the shop items were left behind and locked and key. Later on it came to know that all my valuable household properties were vandalized and looted by unknown armed kuki miscreants. The approximate value of my damaged/looted properties is Rs.10,00,000/- (Rupees Ten lakhs) approximately. However, I could not know the exact date of the incident but it may be in the month of May, 2023. I could not submit my written complaint report to the concerned police Station timely due to the prevailing law and order situation as well as I along with my family members used to stay at Relief Camp.

It is therefore, requested to kindly lodge an FIR and taking up necessary legal action against the unknown armed miscreants.
