## 12. First Information contents:

Mr Mahfuz Alam (Bharat Vanijya Eastern Pvt. Ltd) Submitted a report to Singngat Police Officer-in-Charge stating that an unfortunate incident that occurred on the night of August 19<sup>th</sup> 2024 at our project site camp situated in Maukot village at km 44+400. Around 11pm, a group of 15-20 armed miscreant attacked our site camp and looted out construction materials. Despite the presence of four state Police personnel, they were unable to intervene and prevent the theft.

The miscreant who were carrying deadly weapons arrived with six local Tata vehicles and forcefully snatched approximately 25 MT of TMT steel bars from our site camp. As an EPC contractor, we find ourselves in a state of helplessness and urgently seek your immediate assistance by lodging an FIR and taking legal action against the perpetrators. Additionally, EPC Contractor urgently request the deployment of Central Forces to safeguard our site and prevent frequent attack.
