12. First Information contents:



Today i.e. 19/10/2024 at about 5.40 am some unknown armed miscreants suspected to be Kuki militants and Hmar Village Volunteers attacked Borobekra Police Station from Jakuradhor part-2 area which is about 200/300 meters east from Borobekra Police Station by firing with sophisticated weapons including bombs. The unknown miscreants also gutted 3(three) houses and damaged/dismantled 2(two) another houses located at Jakuradhor part-2 by using Bombs/Explosives. The Police, 7th IRB, and D-20 CRPF personnel also retaliated the fire and there was exchange of heavy firing. In the meantime 1(one) BP Scorpio Vehicle was also rushed towards the firing site and retaliated the fire and later on the unknown miscreants fled away towards unknown destination. The firing was lasted for about 1(one) hour. The bullets fired by the unknown miscreants hit 3(three) rounds to the BP Scorpio Vehicle and some others to the sentry posts and pre-fabricated houses including one refrigerator which was kept inside the pre-fabricated house.

It is pertinent to mention here that in a press release issued by the Hmar Village Volunteers (Pherzawl District & Jiribam District) on 18/10/2024, a stern warning to all the Meiteis, Police, IRB and even Central Forces of Barak Circle to leave the place and move to Jiribam Town before sunset of 18/10/2024 if they value their lives, failing to comply the warning, any untoward eventuality shall be their sole responsibility.

Hence, a suo-motto case under FIR No.25(10)2024 BBK-PS u/s 313/109/326(g)/324(4) BNS, 25(1-C) A. Act & 3 Expl. Subs. Act. has been registered for investigation.
