Subject: Prayer for converting UD case No. 1/SGT-PS/2024 U/S 194 BNSS 2023 into Regular case u/s 103(1) BNS 2023.

Sir,

In reference to the above cited subject, I have the honor to state that one Mrs. Jessica Manneikim (28) Yrs w/o (L) Khamthanlian @ Henry of Dinthar Veng, Nghathal Village, Churachandpur lodged a written complained report that on 22nd October, 2024 at around 7:00 am, her husband Mr. Khamthanlian @ Henry along with Mr. Tanlian of Gangpimual village went for Fishing at T.Khajang Village, Singngat Sub-Division. That She contacted with her husband at @ 09:57 am on the same day i.e 22/10/2024 after which she was not able to contact her husband anymore. On 23/10/2024 she got a call from her Mother who is in Delhi for medical check up told her that her husband is in critical condition. On further enquiry to her relatives she came to learnt that her husband has expired and his body is brought to District Hospital, Churachandpur. She further request that to kindly investigate the case of her husband's sudden death. Hence the case.

During the course of investigation, conducted inquest over the dead body of (L) Khamthanlian @ Henry at the spot, drawn a rough sketch Map of the PO with proper index, examined a good number of Pws on the spot. The dead Body was brought and kept at District Hospital Morgue, Churachandpur. Post Mortem examination was onducted on the 26th October, 2024 by the concerned professor, Department of Forensic Medicine and Toxilogy, FMT, JNIMS Porompat, Imphal at District Hospital Morgue, Churachandpur.

On further course of investigation, the companion of (L) Henry namely Mr. Zamtanlian who went fishing with him on that fateful day, his statement was taken on the 26th October, 2024 and again on the 1st November, 2024 and 2nd November, 2024. His statement keep changing which results in highly suspicious that he is hiding the truth or fact. He later admitted that he had a fight with the deceased person namely Henry on the night of 22nd October, 2024 @ 08:30pm in front of the Hut of Mr. Khaizagin. During the fight Mr. Tanlian throw Henry on the ground twice and pinning down to the ground. After which, Henry left the Hut and proceed towards T.Khajang Village after a short while Tanlian also ran after Henry. Tanlian stated that he did not came across Henry on his way to the Chief's House that Night. The Dead Body of Henry was found by himself lying on the roadside the next Morning. On contrary to his statement, the Road leading to the village was narrow and not noticing the dead body of Henry who is lying on the road is doubtful. Moreover, Tanlian warn/threatened the Hut owner Mr. Khaizagin and his wife saying that " You have to say that I spent the previous Night at Your Hut and that I left in the Morning, you should not disclose to anybody" which in reality he was spending the night at the House of the Chief of Khajang Village.

Based on the facts and circumstances, it is highly suspected that Mr. Tanlian is the prime suspect person in connection with the dead of Mr. Henry.

I therefore request you to convert the UD Case No. 1/SGT-PS/2024 u/s 194 BNSS, 2023 into 103(1)BNS, 2023 for further investigation and necessary action.
