

Sir,

I the undersigned beg to report for your kind and necessary action.

That, on 3rd May 2023 at around 7:00 pm while I was at my resident located at Hmarveng P.S Churchchandpur P.O Tuibong District Churachandpur, Manipur some unknown armed miscreants attacked my house and completely destroyed and burned down all the household properties worth somewhere around Rs.13,49,500/- (Thirteen lakhs forty nine thousand five hundred) approximately.

That, the unknown miscreants are suspected to be Kuki tribal group as they conversed among themselves in the Kuki dialect while they looted and firing by sophisticated weapon and then set on fire my house and properties.

That, the unknown armed miscreants warned and threatened to us to leave Churachandpur town permanently and that, we will face dire consequences if we returned to Churachandpur town again.

Delay of filling F.I.R is due to displacement and inconvenience of my health problem. In the view of the facts and circumstances, apprehend them and punish them in accordance with law.
