Subject:- Report.



Sir,

I, the undersigned have the honour to state that I have resided at the rented house of Mrs. Chingneikim Vaiphei, of Compound Veng (Leimram), Churachandpur since by birth. On 3rd May, 2023 a peace rally was marched at Churachandpur District by a large number of Kuki community. After that, at around 5:30 pm a large number of unidentified people belonging to the Kuki community with deadly weapons and sophisticated arms including Kuki militant groups stormed the Meitei inhabited areas of Compound Veng (Leimram), under Churachandpur P.S., Churachandpur District. The said unidentified groups looted all my household materials including furnitures, electronic items, Gold ornament, Money and personal documents. In such terrible acts of the said unidentified groups, I along with my family members ran away to save our life and hid at Don Bosco Hr. Sec. School, Churachandpur and took shelter at 36th Sector Assam Rifle. Then the 36th Sector Assam Rifle brought us to Moirang and took shelter at Laisoi Regional Water Complex, Relief Camp of Moirang and now staying at the relief camp of KP College, Hiyangthang since 12/08/2023. I have lost my property amounting to a total amount of Rs. 30,00,000/- (thirty Lakhs) only.

It is therefore, requested kindly initiate and take necessary legal actions against the accused persons involved in the said inhuman and barbarous act, as per law of the land as early as possible. I couldn't able to submit my complain report in time due to prevailing inconvenient situation.


