

2. That the value of lost/damaged properties is around 45,20,000/-
3. Delay in lodging complaint is due to the prevailing law and order situation in Manipur. I am taking shelter at Meitei Langol Leima Khullen Leikai relief camp. Along with my family members till date.

It is therefore request you to take up the necessary action accordance with the law against the unknown miscreants suspected to be Kuki militants.
