


Subject: Report on the ransacked of Legal Cell, ITLF located at the 1st floor of District Library,
P.O., P.S. & District- Churachandpur, Manipur.

With references to the above cited subject, I have the honour to report to you as follows:

That, on the 22nd day of Dec., 2023 at around 11:20 AM, while opening the lock of the office, it came to my knowledge that the office had been ransacked, there were 1 (One) broken plastic/ melamine serving plate on the floor, most of the office chairs were flipped upside down, some important files were scattered, the office paper bin was on the table placed upside down, coffee mugs were lying around the floor and the stationary such as pen, pencils, etc were scattered all over the floor and table, which was caused by an unknown miscreants.

That, the criminal activities took place from between the 19th of Dec., 2023 at around 4:30PM (when the door of the office was ~~locked~~) and the 22nd of Dec., 2023, around 11:20AM (when the office was opened to resume work). It is suspected that the miscreants had used the sliding window as entrance and also the exit point, since the lock on the office door was undamaged.

That, it is to report that none of the office item' remains to be missing nor stolen so far, in the case of any unrecorded missing files or documents, it remains my duty to report the same to you.

Therefore, I humbly pray you to kindly register an FIR, investigate the matter and book the perpetrators under relevant laws of our Country. And for which act of kindness I shall always remain grateful to you. Thus, I am filing this application today.
