Received an information that one Public Notice signed by Ngulmang Haokip, Convenor, United Tribals Volunteers, Indigenous Tribal Leaders' Forum (ITLF) was found widely circulated stating that all borders within Lamka District and Manipur (Bishenpur) will be sealed for security reasons due to input about an imminent threat by the Meitei to disrupt the Christmas Season from 23/12/2023 to 05/01/2024, all non-tribals within the district are not allowed to move out of the district and those non-tribal from outside are not permitted to move inside the district. This statement/ notice can lead to enmity between different groups, giving provocation with intent to cause riot, can causes wrongful restraint, danger, obstruction or injury to any person in any public way or public line of navigation.

Hence a suo-moto case under FIR No. 2967(12)2023 CCP-PS u/s 153/153A/283/341/34 IPC is registered against Ngulmang Haokip, Convenor, United Tribals Volunteers, Indigenous Tribal Leaders' Forum (ITLF) and its cohorts for investigation.


