This statement/ notice can lead to enmity between different groups, giving provocation with intent to cause riot, can causes wrongful restraint, danger, obstruction or injury to any person in any public way or public line of navigation.

Hence a suo-moto case under FIR No. 2967(12)2023 CCP-PS u/153/153A/283/341/34 IPC is registered against Ngulmang Haokip, Convenor United Tribals Volunteers, Indigenous Tribal Leaders' Forum (ITLF) and its cohort for investigation.
