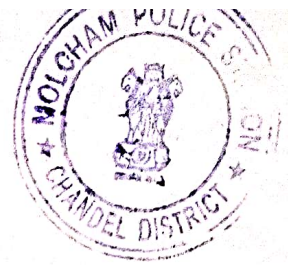

- (a) I, have the honour to submit the report that based on a reliable inputs by unit source at around 1600 hrs on 26 Dec 2024 regarding move of War like Store towards Moreh through Changpol & Gamphazol, both notified area. Multiple MVCP were established at general area Changpol, Zoldam and Gamphazol. At approx. 1730 hrs MVCP of 01-01-20 under Capt. Swadhin Hazary which was established at general area Changpol (RM 724018) intercepted one Maruti Suzuki Eco-Van with veh registration No. MN01X-2594. Upon detailed search recovery of wpns was done in which 01x AK-56 Assault Rifles, 01x Rifle LM-16 (Type 81 Assault Rifles) was recovered and apprehension of two Indian Nationals was done.
