Today i.e 02/02/2024 at 7:00 PM, a video clip was found circulated in the social media in which a group of persons, who claimed themselves to be members of *Lomikang Som*, were seen engaging in erection of new Cross at Thangjing Hill top, a place of worship of the Meiteis. Some of the persons were seen carrying firearms. Two persons who talked to the anchor identified themselves to be one Mr. Henjakhup Haokip and Mr. KB Vaiphei. The incident is said to have been held on 26/01/2024, at about 11:00 AM. This amounts to deliberate and malicious act intended to outrage religious feelings of any class by insulting its religion, and promoting enmity between groups on grounds of religion.

Hence, it is considered to register a suo-motu case under FIR No. 1(2)2024 HLP-PS U/S 153-A/295-A/400/34-IPC and 25(1-C) Arms Act, for investigation.
