Subject :- **Report on Looting, Vandalism and burning down of house, household items/assets, Documents and Discrimination of Schedule Tribe.**

Sir,

With reference to the above cited subject I have the honour to report to you as follows :

1. That I, **Chinitkim Mate**, aged about 20 years **W/o Thangminlian Mate**, Belonging to **Mate Tribe** Community, a schedule Tribe recognized under the constitution of India, by virtue of which I am being entitled to the protection under **The SC/ST (Prevention of Atrocities) Act, 1989**, and that I am a permanent Resident of **Khuangmun Village, District Churachandpur, Manipur. P.O&P.S., Churachandpur.**
2. That at about **10:00 pm** on the **3rd May 2023**, a huge contingent of armed radical meeitei/Meitei suspected to be members of the **Arambai Tengol and Meetei Leepun** along with Police Commando and a mob numbering about 1000 attacked our Village with sophisticated weapons. so in order to save their lives my family have to run for their lives leaving behind our house along with all our household items and properties. And in the process they have looted then burnt down my house including all our household items, Documents, our Domesticated animals (3 Goat).
3. That, it may be reported here that the above said criminal activities have caused grave mental agony and incurred huge loss which may be estimated to be **Rs. 15,00,000/- (Rupees Fifteen Lakhs) only.**
4. Fortunately, my family managed to escaped from the criminals who even tried to kill them, and now we are currently taking refuge at **Teiseng Relief Centre Teiseng Village Churachandpur.**
5. That, I am filing this information lately because there is a great danger to my life and due to which I was at different places to save my life and now I am able to restore my health and settled at The above mentioned address. And thus, I am filing the report lately today.

In the given circumstances, I humbly pray you kindly register an **FIR**, investigate the matter and punish the perpetrators as per the prevailing provisions of the laws of our country. And, for which act of kindness, I shall always remain thankful to you and obliged.
