



Today, 10-05-2024 at 06:30 p.m. received reliable information from source that on the same day at around 4:30 pm, a group of unknown armed miscreants suspected to be UKNA cadres trespassed into the Labour Camp of BIPL, who are executing road construction work between Thingkeu and Henglep, near N. Saikot Village, Henglep Sub-Division, Churachandpur. Source revealed that the said unknown armed miscreants warned the labourers present there of facing dire consequences if their monetary demand earlier were not paid. Later, they (unknown armed miscreants) forced the driver of Bolero Camper, belonging to BIPL, to drop them to some undisclosed location.

Hence, a suo-motu case under FIR No. 6(5)2024 HLP-PS U/S 384/400/451/506/34-IPC & 25(1-C) A. Act, has been registered for investigation.
