

Complainant against the unknown kuki militants for commission of offences punishable under attempt to Murder, assault, dacoity, threat to life, criminal intimidation, burning of place of worship (Kula Devata/ Sagei God, Meitei God "Laining Thou Sanamah", Criminal Trespass, rioting and other provision of law under Indian Penal Code, 1860.

Place and date of occurrence:-

Khumujamba Meitei Leikai, Churanchandpur District, Manipur, The 3<sup>rd</sup> May, 2023.

Sir,

With due respect, it is to state that I am a permanent resident of Khumujamba Meitei Leikai, Churanchandpur District, Manipur. I have been working hard for development

Manipur Society, particularly in education sector, including all the community in the state of Manipur. I opened a hostel cum private coaching centre in the name and style "Academy" at Khumujamba Meitei Leikai, Churanchandpur District, Manipur.

I further beg to report to you that on 3<sup>rd</sup> May, 2023, a rally was organised by some tribal Communities in Churanchandpur District, Manipur. Further, it is gathered that Kuki-Zo Community along with kuki militants started burning government offices and houses of Meitei Community at TORBUNG BANGLA VILLAGE.

It is further reported that a pre-planned chart has been made by the armed kuki militant to destroy all the house of the Meitei Community in and around



the Churachanpur town. After destroying all the houses of Meitei Community at Torbung Bangla Village, the armed kuki militants numbering around 200 first attack my house which is located at peripheral area at that place.

As stated above I was running hostel cum private coaching centre at my resident. The kuki militant numbering about 200 people with sophisticated weapons, petrol bomb and other deadly weapon attack my house wherein my family members numbering 10 persons and students in my hostel were staying, the details of which are given below.

My family members :-

1. Mairembam Ibotombi, (aged 86),
2. Mairembam Premkumar Meitei, (aged 51)
3. Mairembam Thoibi, (aged 50)
4. Myself.
5. Mairembam Kanta Meitei, (aged 29),
6. Mairembam (O) Anandi Devi (29),
7. Themba Mairembam (25),
8. Kavita (17)
9. Mairembam Gracia (aged 1 and half).

Some of the students staying at My hostel :-

It is further respectfully submitted here that my students are staying at the first floor of my house. At around 5.45 PM of 3<sup>rd</sup> May, 2023, Kuki Militants numbering 200, came to my house and suddenly throw petrol bomb and stones towards my house. The Kuki Militants were also equipped with sophisticated Guns. Out of fear and to save their life my students jump from 1<sup>st</sup> Floor of my house and many were seriously injured. My family members and my students run here and there to save our lives. My family members and students were also assaulted by the Kukis Militant and they even fire with from their sophisticated gun towards us. They forcefully entered my house and have also taken all our belonging. The Kukis Militant have committed the offences of attempt to Murder, assault, dacoity, threat to life, criminal intimidation, Criminal Trespass and others as provided under Indian Penal Code. They also burnt down my house.

I and my family members are Meitei by religion. Since the time of my forefather, there has been temple built within my family homestead land for worshipping our Kul Devata/ Sagei God, Meitei God "Laining Thou Sanamahi" and I and my family worship our almighty every day. The Kuki Militants have destroyed all the above scared place mentioned above thereby committing offences of destroying place of worship. There are 205 houses in my locality and every house have built their place of worship and the kuki Militants have destroyed it in ash.

It is respectfully submitted here that I could not file the present Complaint earlier as I was totally shocked of the incident and took time to recover from the trauma, move-over, I and my family were searching for a place to stay. For destruction of my house, I had already made a complaint to the Moirang Police station. However the destruction of our place of wordship and other



offences/crime committed by the kuki militants has not been brought to the authority. Hence this Complaint.

I further beg to state that I am now staying at Lamphel Sanakeithel Supermarket, and as such I am filing the present Complaint to Your Good self police station praying for investigating into the matter and booked the culprits by making arrest for commission of offences of attempt to Murder, assault, dacoity, threat to life, criminal intimidation, burning of place of worship (Kula Devata/ Sagei God, Meitei God "Laining Thou Sanamahi", Criminal Trespass and other provision of law under Indian Penal Code, 1860 for the end of justice.
