Subject: - Report of destruction and loss of household materials of my residence located at Khugatampak, Mamang Leikai Old Bazar under Churachandpur Police Station.

Sir,

I, the undersigned have the honour to report that on 03/05/2023 at around 8:00 pm all my properties were looted and my house was burnt down by large number of unidentified people belonging to Kuki community bearing deadly weapons and sophisticated arms, backed/supported by suspected armed Kuki militants who stormed Meitei inhabited areas and village. The said unidentified armed group vandalized/looted/burnt down my house located at Khugatampak, Mamang Leikai Old Bazar, Churachandpur and looted all valuable item. The total values of my properties and residence is worth around Rs. 39,00,000/- (Thirty-Nine Lakhs) only. Delay in lodging complaint is due to the prevailing law & order situation in Manipur and also under medical treatment at Chandigarh.

It is therefore, requests you to take necessary action in accordance with the law and against the unknown miscreants suspected to be armed Kuki militants.
