Subject: FIR against theft of Telecom Equipment i.e. Delta IPMS (Integrated Power Management Systems) sabotage at our Mobile Tower UMP554 (IN- 2063785)

Sir,

With reference to the subject cited above, this is to inform you that on 19/06/2024 14:00:00PM, Technician visited the site UMP554, at residence of Mercy Chinneihat, D/O- Chinkhotin, Vill- New Pangsang, PO- CCPUR, PS- Henglep, Dist- CCPUR, State- Manipur, Pin- 795128.

Accordingly, it is found that some unknown miscreants had barged into the tower site and sabotaged the network equipment, namely, Delta IPMS (Integrated Power Management Systems) with an ulterior motive of monetary gain and disrupting communication.

The Delta IPMS (Integrated Power Management Systems) is a device which supplies power and deployed at Airtel mobile towers for maintaining communication and it is installed mainly at the base of the mobile.

Frequent unabated thefts of these kinds of equipment from our tower sites have impacted the very communication network though replacements of the equipment subject to availability are made immediately to maintain network. It is to be mentioned here that because of the huge number of thefts taking place in the Circle, we are running short of such a stock of equipment for replacement.

In view of the above, I request you to kindly register a case in this regard and investigate the same to bring the culprits to book and recover the stolen items at your earliest possible.
