Subject: Report on crimes of unlawful displacement, looting, property destroyed and discrimination of Scheduled Tribes.

With references to the above cited subject, I have the honour to report to you as follows;

I am a scheduled tribe belonging to the Any Kuki Tribe, which is a recognized tribe under the Constitution of India and a permanent resident of G. Mongjang Village, Kangvai, P.O., P.S. & district- Churachandpur, Manipur.

That, due to the ethnic crisis in the State of Manipur, we deserted our above mentioned house on the 3rd of May, 2023 at around 3:30 PM, to save ourselves from the warmongers Meetei/Meitei community and during our absence, a mob of Meetei/ Meitei suspected to be members of Arambai Tengool, Meitei Leepun, Valley Based Insurgent Groups (VIBs) and the local in and around the area attacked our village with sophisticated weapons from an unknown location (Meitei/Meetei' area), destroying the roof of my house bomb shells & bullet holes, which was fired from their sophisticated weapons, causing damages to the movable assets of the house, on the 4th of May, 2023 at around 7:40 PM. Whilst, we deserted our above mentioned house, my son namely, Lalsanglien's Two Wheeler, Yamaha, FZ model, Red in colour, bearing Vehicle No. MN01 U 1793, computer & other electronic items and other household items were looted by unknown miscreants.

That, it may also be report that the said criminal activities have cause grave mental agony and incurred huge lose which is estimated to be about Rs.12,00,000/- (Rupees Twelve Lakhs) Only, inclusive of my household items/ movable, roof of the residential house and my sons' Two Wheeler vehicle with his electronic assets.

That, I am filing this report lately as we were taking shelter at cousin's village (Singngat sub-div) for many months cultivating crops & other vegetables. Therefore, I humbly pray you to kindly register an FIR, and book the perpetrators under the relevant laws of our Country. And for which act of kindness I shall always remain grateful to you. Thus, I am filing this application lately today.
