

Subject : Report on crimes of unlawful displacement, looting, attacked and indiscriminate firing at our Village.

Sir,

With reference to the above cited subject, I have the honour to report to you that On 7th May 2023, around 500 Meitei Extremist along with Arambai Tenggol who came from Haotah Vajang Village suddenly attack our Village Lhangnomphai, Dampi, Churachandpur around 3:30 pm and start firing indiscriminately at everyone from the hill top of Village. So we had to flee for our life as we had no choice other than fleeing which causes heavy loss of Property along with 6 Cows, 6 Pigs, 50 Ducks, 40 Local Hens and 50 Bags of Food Grains.

The estimated property loss is around Rs. 2,25,000.
