






With references to the above cited subject, I have the honour to report to you as follows;

I am a scheduled tribe belonging to the *Any Kuki Tribe*, which is a recognized tribe under the Constitution of India and a permanent resident of G. Mongjang Village, P.O., P.S. & district-Churachandpur, Manipur.

That, on the 3rd of May, 2023 at around 3:20 PM, a mob of armed Meitei/ Meitei suspected to be members of Arambai Tengool, Meitei Leepun, Meira Paibis along with the locals in and around the area, attacked our area, in the process they have arson-attacked/ burnt my rented house owned by namely, Lunsat Baite(8798988059) located at Torbung Bazar, Torbung, P.O., P.S. & District- Churachandpur, Manipur.

That, it may also be report that the said criminal activities have cause grave mental agony and incurred huge loss which is estimated to be about Rs.5,50,000 (*Rupees Five Lakhs Fifty Thousand*) Only, inclusive of the the household items / movable assets along with items/stocks for the shop which I was planning on opening (ADCC documents on pending).

That, *I am filing this report lately as the sole bread earner of my family, I was at Behiang village area for months, working as a labourer/ daily wager.*

Therefore, I humbly pray you to kindly register an FIR, and book the perpetrators under the relevant laws of our Country. And for which act of kindness I shall always remain grateful to you. Thus, I am filing this application lately today.
