With reference to the above cited subject. I have the honour to report to your good office as follows:

That, I, Khailalmuan aged about 34 years S/o (L) Soincilam belonging to the Vaiphei tribe/community, a Schedule Tribe recognized under the Constitution of India, by virtue of which I am being entitled to the protection under The SC/ST (Prevention of Atrocities) Act, 1989.

That, I would like to inform and register a cognizable offence carried against me and my family at our owned house located at Kangvai Village, Churachandpur District. P.S- Churachandpur.

That, on the 3<sup>rd</sup> of May, 2023 at around 3:30 PM, a huge contingent of armed radical Meeitei/Meitei suspected to be members of the Arambai Tenggol and Meetei/ Meitei Leepun attacked our village and in the process burnt down my Two Wheeler Vehicle bearing Regd. No. MN02A7249; Colour- Black, Model - Discover, and in the following days when the attacked continues our household items were vandalised by bullets and mortar fired by the Meitei miscreants and domesticated animals were being looted.

That, it may be reported here that above said criminal activities have caused grave mental agony and incurred huge loss which may be estimated (approx.) to be Rs 7,00,000 /-(Rupees Seven Lakh) only.

I am filing this report lately since I have been at different places for safety and not able to cope with the mental trauma. Now, since I am able to settle myself physically and mentally, I am in a position to file a report today. Hence, prayed that my report be accepted.

In the given circumstances, I humbly pray you to kindly register an FIR, investigate the matter and punish the perpetrators as per the prevailing provisions of the laws of the land. And, for which act of kindness, I shall always remain thankful to you and obliged.
