

Shri Ginminlal aged 34 S/O Genpu Vaiphei of Kangvai village Churachandpur District Manipur

That, I am a victim in the ongoing Ethnic violence in Manipur and such as I am filling this First information Report (FIR) to submit and state what I have encountered on 3<sup>rd</sup> May 2023 in my village at around 4:30 PM, I heard Meitei mob shouting and chanting in around my locality and started burning houses belonging to Kuki-Zo Communities since the clash has turned ugly it was not safe for me. I head toward Assam Rifle Camp at Kangvai village taking shelter at the Camp on the next day I went to see my house but it had been vandalized and all my properties along with important documents by unknown miscreants. The total estimate of my properties which has been vandalized and looted/ stolen is estimated to be around 5 lakhs three thousands only.

On 24<sup>th</sup> February 2024 I have written a report to the officer- in- incharge Churachandpur Police station regarding report on looting vandalization of household items and assets.

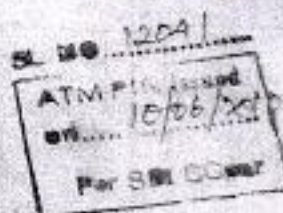
